I acknowledge that failure to follow training advice may lead to a less than optimal result and do not fault Saved By A Rescue.

I (client) _____ agree to schedule regular training sessions as agreed upon with Saved By A Rescue to obtain the best result possible for my dog.

I realize that failure to maintain a training schedule may lead to a less than optimal result and do not fault Saved By A Rescue.

I (client) _____ agree to give 12 hour notice if a scheduled session must be cancelled. Failure to notify of cancellation in a timely manner will result in the normal session fee being charged for the missed session.

I (trainer) _____ agree to provide the best training advice to the client to ensure the best outcome with their dog. I agree to change methods if I think it may enhance and give a better result for the client.

I (trainer) _____ agree to show up at scheduled sessions on time and in a professional manner.

I (trainer) _____ agree to give 12 hour notice to the client if a scheduled session must be cancelled. Failure to notify in a timely manner will result in a free training session (no charge) for the client.

Terms and Conditions

Contract can be voided if one of the following conditions apply:

1. 3 consecutive sessions have been missed/cancelled
 - a. Client is still responsible for payment for missed sessions
2. Payment is declined/incomplete
 - a. If training has been provided, the client is still responsible for payment of the sessions completed. If no training has been provided, no payment is required.
3. Trainer and Client agree to void the contract for reasons agreed upon by both parties.
 - a. As long as training up to the point of termination has been paid for, no further payment is required. If the entire session/package has already been paid for, the trainer will reimburse the client for unused sessions.
4. Client may void the contract if the Trainer is unprofessional.
 - a. Full refund will be given to the client.
